**Educational Objective of the program:**

The UIC Observation Program in Prosthodontics provides a meaningful educational opportunity for Dentists interested in gaining knowledge in a short term continuing education experience that covers all aspects of Prosthodontic and Implant practices and procedures.

\*\*Please note that participants in the program will need to be full time to attend departmental seminars of Prosthodontics and Implants

Attendees/Participants experience through observation and discussion a wide range of Prosthodontic and Implant procedures in the Comprehensive Dental Implant Center from 9:00am to 4:30pm. No direct patient care by the observer is permitted.

**Tuition:**

Tuition for the Observation program for the 2013-2014 academic year is as follows:

Daily Rate-\$110

1 week (Mon-Fri)-\$550

2 weeks-\$1100

3 weeks-\$1650

1 month-\$2420

3 months-\$6270

6 months-\$12,100

1 year-\$23,760

Half of the non-refundable rate is required one week after being notified of your acceptance into the observation program. The remaining half of the none-refundable balance is due on the first day of your observation. All payments are non-refundable.

**Admission Requirements:**

1. Volunteer-Extern Registration Form
2. Original Transcripts (has to be sealed and sent directly from your dental institute). If your transcripts are not in English, a professional translation is required at the observer's expense.
3. Copy of your Dental Degree
4. Completed medical immunization form (found in the registration form).
5. Other information as requested by the Department. For example, letters of recommendation as requested.

**Evaluation outline at completion of the program for CE credits:**

The CE credits are based primarily on attendance and level of activity and participation within the observation program. Individuals are awarded 0.5 CE Credit for each four hours of participation (e.g., 1 hour for a full day). A maximum of 75 CE credits are awarded. Students receive a certificate of CE participation upon completion.
